SETTLEMENT OF BPT CASE

It is well known that civil litigation can be very costly and take a very long time to resolve. As you may be aware, the landfill and Williams Township were able to settle before the start of a scheduled trial the dispute over the Township's previous Business Privilege Tax (BPT). We jointly announced at the time that the settlement is a fair one in which both sides compromised for the benefit of the entire community. The complete settlement agreement can be found on the Township's website. We are gratified that as a result of the settlement the 2009 Host Community Agreement (HCA) between the landfill and Williams Township is reaffirmed and that the previous BPT ordinance was repealed once and for all.

Many have also come to recognize that the settlement leaves rock solid all conservation and recreation-related benefits of the host agreement, including with respect to the new and highly popular Chrinergy-Williams Township Sports Complex.

WILLIAMS TWP. SLASHES TAXES

One newspaper headline hailed a 'miraculous' tax cut for Township taxpayers. Township Supervisors, on the heels of the BPT case settlement, have taken action to cut the property tax rate 43% from 4.0 to 2.25 mills for the year 2016. This restores the tax to the lowest rate in Northampton County, creating substantial savings to the residents of Williams Township.

INCREASING DISPOSAL = ADDED REVENUE

The Host Agreement permits expansion within the established solid waste zoning district. That process is now underway following the filing of our 10-year expansion permit application with the Pennsylvania Department of Environmental Protection (DEP). A full copy of the filing is available at the Township building, and it includes numerous detailed

engineering drawings. Breaking it down, it is important to consider the following about the proposed expansion:

- i. No additional property will be acquired to accommodate the proposed increased volume. The current boundaries of the Solid Waste Zoning District remain the same.
- ii. The maximum daily waste disposal tonnage limit would not be increased since the amount of daily/weekly disposal vehicle traffic would be unchanged.
- iii. If approved, there would be a positive revenue impact on Williams Township: \$1 per ton additional over current levels. This represents a 33% increase in host fees to the township.

DEP will continue to post public meeting notices related to the proposed permit process, as will the township.

SLIDE REMEDIATION STATUS

From time to time we are asked about progress on remediating the movement – or slide – of a closed/covered section of the landfill a few years ago. It has been a significant and meticulous engineering and construction undertaking. Safety for our workers and the benefit of our community from day one has been our highest priority. And safety takes time. We are pleased to report that we are in the final stages of the excavation and the relocation of the waste from the two affected sections. With oversight and approval from DEP, we will eventually be relining the slide section and recommissioning it. Of course, we continue to work closely with the Township and have greatly appreciated its interest and input.

FREE COMMUNITY MULCH DAY

We continue to offer free mulch recycling to the community. 2016 will be our 16th year for providing truckloads of double-cut hardwood mulch; usually 200 or so truck loads per Saturday. The next mulch give-away will take place 7:30 a.m. – 11 a.m. on Saturday, April 23, 2016.

We have worked closely with the Township, the Recreation Committee in particular, and the various youth athletic associations to make sure that the fields would be built right and to last for many years to come for the enjoyment of the boys and girls in the community. We hope you've had the opportunity to visit the complex, perhaps catch a game, and imagine that this site will only improve over time with the commitment of all involved. For our part, we look forward, as part of the expansion process, to eventually transferring complete ownership of the site to Williams Township. CHRIN: THE NEXT GENERATION

Greg and Caryn Chrin's two twenty something sons, Charlie and Gregory, figure prominently in the present and future operations of the landfill. Charlie, named for his grandfather, and Gregory, named for his dad, are both college students (Charles/Environmental Science, Lafayette College, Gregory/Mechanical Engineering, Stevens Institute) that spend almost all their non-academic time working at the landfill. That's hardly surprising given the fact they both have a passion for the environment, the family owned and operated business, and the communities it serves in the Lehigh Valley.

Charlie is an operations manager with wide ranging responsibilities, including helping to manage the field crews, interacting with various environmental, engineering, and other technical experts and agencies, monitoring landfill daily efficiency and ensuring over-all compliance. The brothers also work closely in relation to the landfill's innovative co-generation energy facility (housed in Glendon) that transforms landfill-produced gas – the result of decomposition – into electricity. Gregory is in the process of installing within the landfill his patent-pending gas monitoring system. Developed as his senior thesis, it will eventually enable Chrin and other landfill operators to significantly improve the amount of methane gas that can be retained and used in power production. Each well monitor, which can be read 24/7 from either a central monitoring station or a handheld device (such as a smartphone), may eventually replace individual, labor-intensive gas well monitoring. Charlie and Gregory, whose first jobs at the landfill included power washing trucks and weed whacking, readily admit to being not only compatible co-workers, but also best friends.
